## 2. Optional author credit

If the Contribution is used, Publisher may credit Contributor by legal name, preferred credit name, initials, or anonymously, as requested by Contributor where practicable. Credit, placement, and form of credit remain in Publisher’s editorial discretion.

## 3. Assignment of rights

Contributor hereby irrevocably assigns and transfers to Publisher all right, title, and interest in and to the Contribution, including all copyrights and all rights of publication, reproduction, distribution, display, adaptation, editing, excerpting, translation, audio use, promotional use, archival use, and licensing, in whole or in part, in all languages, formats, and media now known or later developed, throughout the world, to the fullest extent permitted by law.

## 4. Editorial discretion

Publisher may accept, reject, edit, copyedit, shorten, retitle, excerpt, combine, annotate, adapt, or decline to use the Contribution in Publisher’s sole discretion. Submission does not guarantee publication.

## 5. Contributor warranties

Contributor represents and warrants that the Contribution is original to Contributor, or that Contributor has obtained all permissions necessary for any third-party material included; that the Contribution does not knowingly infringe copyright, privacy, publicity, or other rights; and that it is not knowingly defamatory or unlawfully invasive of privacy.

## 6. Supporting materials

If Contributor submits photographs, letters, emails, journals, or other supporting materials, Contributor affirms that Contributor owns them or has permission to submit them, and grants Publisher the same rights described above for use in connection with the project.

## 7. Release and indemnity

Contributor releases Publisher from claims arising from good-faith editorial use, non-use, or modification of the Contribution consistent with this Agreement, and agrees to indemnify Publisher against losses arising from breach of Contributor's warranties.

### 8. Governing terms

This Agreement contains the entire understanding regarding the Contribution. Electronic or printed copies are equally valid, but for this version the Contributor is being asked to sign and mail a paper copy to Publisher.
